Notice of Publication of Proposed Tariffs

[1] In accordance with section 68.2 of the *Copyright Act*, the Copyright Board publishes today all proposed tariffs filed in 2025 on its [website](#). The list of proposed tariffs being published can be found in the Annex.

[2] The Board also publishes, as per subsection 17(2) of the [Copyright Board Rules of Practice and Procedures](#), the notices of grounds for the proposed tariffs and the comparative documents as filed by the collective societies.

[3] The Board gives notice to persons affected by the proposed tariffs that any objection to a proposed tariff must be filed with the Board no later than **Wednesday, December 17, 2025**.

[4] In addition, in accordance with section 18 of the *Rules*, a person that objects to a proposed tariff must file a notice of grounds for objection.
